1. The first party hereby agrees to occupy accommodation in Working Women Hostel, Sector 24 Chandigarh on a purely temporary basis and will be liable to vacate the accommodation on as and when required by Second Party to do so.
2. That the first party agrees that the accommodation offered to her in the Hostel will be for a period of 11 months in the first instance and the first party will be liable to vacate the accommodation as and when required by second party even before the expiry of the period of said 11 months upon service of one week's notice on the first party by the second party to that effect without assigning any reason and the first party will vacate the accommodation peacefully and without hindrance.
3. That the party will be entitled to obtain in the accommodation beyond the aforesaid period of 11 months only if this period is renewed by the Hostel committee of the Working Women Hostel.
4. That the first party has read the rules and regulation for the admission and stays in Hostel and agrees to abide by them, the first party further agrees that any change or modification in these rules and regulation will be binding on the first party during the period of her stay in the hostel.
5. That the first party will be pay the monthly hostel fee and other sundry charges like water, electricity etc. As decided upon the second party from time to time by the 10th month in advance. In default the first party will pay penalty prescribed from time to time in case of default.
6. That the first party hereby agrees that second party shall be entitled to forfeit the security deposited by the first party at the time of admission, or even sell the articles and belonging of the first party to meet the default committed by the first party to property and belongings of the second party.
